

POD/Temporary Movable Storage

Protocol Document | Spring 2023

All Pods must be registered with MIT Parking and Transportation. A Pod Pass must be placed on all pods and they must be placed in a specific parking space while on the MIT campus. To request a parking space for your Pod, please contact MIT Parking and Transportation at:

Important Notes

- Pods will be permitted between **Friday, April 14, 2023 and Friday, May 26, 2023.**
- Cost of one parking space for a Pod is \$34.00 per day for no more than 3 days.

Parking Space Availability

There are a number of available spaces to undergraduate student residents on the west side of campus. What follows is a breakdown of available streets and parking spots:

Undergraduate Houses: West Campus

- **Amherst Alley:**
 - 6 parking spaces for use by residents of MacGregor House, New House, and Next House
 - 6 parking spaces for use by students in Maseeh Hall, McCormick Hall, Baker House, and Burton-Connor House
- **Westgate Lot:** 10 parking spaces on the east-facing fence line for use by residents of Next House and Simmons Hall.

Undergraduate Houses: East Campus

- Random Hall and East Campus residents do not have any MIT-owned spaces available for POD placement. Residents of these residence halls will need to work with the City of Cambridge to purchase City-managed parking spaces, or select from other MIT-owned spaces near other buildings. Graduate Houses: West Campus



- **Amherst Alley: 10** parking spaces on the east-facing fence line for use by residents of Tang Hall and Westgate Apartments. Please note that these spaces are also available for use by undergraduate residents of Next House and Simmons Hall.

Graduate Houses: Northwest Corridor

MIT Parking & Transportation has experienced limited requests for POD spaces from the graduate housing communities. However, the following spaces are available for use by residents:

- **Edgerton House & The Warehouse:** Edgerton House residents do not have any MIT-owned spaces available for POD placement. Residents of these residence halls will need to work with the City of Cambridge to purchase City-managed parking spaces, or select from other MIT-owned spaces near other buildings.
- **Sidney-Pacific: 2** parking spaces on the south side, fence line of the exterior parking lot.
- **Ashdown House: 2** parking space near the loading dock area.

Graduate Houses: West Campus

- **Graduate Tower at Site 4 & 70 Amherst Street:** Spaces for use by 70 Amherst Street and Graduate Tower at Site 4 residents will be located in a loading dock bay within the Graduate Tower at Site 4. Spaces will be assigned by the Graduate Tower at Site 4 [House Operations Manager](#).
